



## Nursing Home Weekly: Recap of LeadingAge Updates

October 1, 2021

**LeadingAge Coronavirus Calls.** On **Monday, October 4 at 3:30, Brian Kane**, Senior Director of Ethics at the Catholic Health Association of the USA will join the call to talk about the thorny and multi-faceted topic of religious exemptions. In particular he will address questions and concerns that have been raised about the use of fetal cells in relation to COVID vaccines currently available. Brian will talk about [this Statement from Pro-Life Catholic Scholars on the Moral Acceptability of Receiving COVID-19 Vaccines](#), from the Ethics and Public Policy Center. He'll answer caller questions and discuss how Catholic health and aging services provider organizations are dealing with religious exemptions. **Highlights from HRSA's first of 4 webinars on new PRF Application:** Thursday's webinar reinforced several things LeadingAge shared with members on Wednesday's Member Coronavirus Call and detailed in the latest PRF [article](#). Here are some highlights: 1) providers should begin the application process NOW because the first step is getting their TIN(s) validated and we know from prior application rounds this is not always an easy task; 2) A new provision has been added to the Terms and Conditions for these funds that requires providers to notify HRSA via the Reporting Portal if they go through a merger or acquisition with any other provider; 3) Providers who were new in 2019 or 2020 are eligible for funds to apply for funds but will have some additional steps in the application process that are outlined in the application instructions; 4) There is no penalty for providers to check "yes" on their application indicating they would like to be considered for the American Rescue Plan Rural funds. A provider will receive some amount even if they only serve one rural beneficiary. So, all should check "yes"; and 5) Rural funds received can only be allocated to the relevant rural TIN. They cannot be allocated to a non-rural subsidiary. As always, reach out to Nicole ([NFallon@LeadingAge.org](mailto:NFallon@LeadingAge.org)) with questions.

**And a reminder - HRSA to host Provider Relief Webinars.** If you missed it, here's an [article](#) about HRSA updates to the Provider Relief Fund website. In addition, HRSA will offer a series of webinars on the next round of PRF payments. There is a webinar on Tuesday, October 5, 3:00 – 4:00 PM ET (sign up [here](#)). They will cover who is eligible to apply, how payments are determined, how the application process works, and how to navigate the application portal and successfully complete an application. Additional webinars will soon be announced for October 11 and 18, with information coming out soon.

**Continuing Resolution Until December 3.** Thursday the Senate and House passed a continuing resolution (CR) to keep federal programs funded absent enactment of annual appropriations bills. The CR will keep federal programs funded at fiscal year 2021 levels until December 3, just more than two months into fiscal year 2022. Congress has not enacted any of its 12 annual appropriations bills. LeadingAge has been assured by HUD officials that FY21 funding levels will be sufficient for HUD-assisted housing programs to continue through December 3. The President is expected to sign the CR prior to

midnight, September 30, before the October 1 start of the federal fiscal year to avert a federal government shutdown.

**Vaccine Mandates: Q & A on Upcoming OSHA ETS For Businesses with 100 or more Employees.** There are a lot of questions about the upcoming OSHA emergency temporary standard (ETS) addressing vaccine mandates or weekly testing requirements that will apply to all employers with 100 or more employees. The Health Action Alliance hosted a town hall last week with three experts and provided some [answers to top questions](#) they received on the upcoming OSHA ETS. We are also awaiting the CMS vaccine mandate for providers that participate in the Medicare and Medicaid program and will review how these two rules will apply to LeadingAge members. We anticipate both rules will be released sometime in October.

**Future of Telehealth Webinar.** On Tuesday, October 5 at 1:00 PM ET, The Hill will host a webinar, The New Role of Telehealth. Among the featured speakers is LeadingAge national Board Member Karyne Jones of the National Caucus and Center on Black Aged. The focus of the session will be on improving patient care and the role of telemedicine in the healthcare system of the US. Questions that panelists will explore include how we approach the balance between virtual and in-person visits, how we fill care gaps and better utilize technology and how we ensure the highest quality for all people using healthcare services. **Regular information for clinicians on Monoclonal Antibodies.** HHS hosts regular stakeholder calls on COVID-19 Monoclonal Antibody Therapeutics. **FROM HHS:**

1. **Resource for Providers Participating in the CDC COVID-19 Vaccination Program, Long-term Care Residents & Their Families:** In response to [inquiries about medical consent surrounding the administration of a booster shot of Pfizer-BioNTech COVID-19 vaccine](#) to residents in long-term care (LTC) settings at least six months after their Pfizer-BioNTech primary series, the Centers for Disease Control and Prevention (CDC) has released responses to frequently asked questions (FAQs).
2. **Studies Show More COVID-19 Cases in Areas Without School Masking Policies:** On Friday, CDC released three studies in the *Morbidity and Mortality Weekly Report (MMWR)* that [highlight the importance of using layered prevention strategies including universal masking to stop the spread and minimize disruptions to school operations for safe in-person education](#). These studies found that school districts without a universal masking policy in place were more likely to have COVID-19 outbreaks. Nationwide, counties without masking requirements saw the number of pediatric COVID-19 cases increase nearly twice as quickly during this same period.
3. **Science Update:** On Friday, CDC [released their weekly COVID-19 Science Update](#). This week's update includes research on the duration of protection of COVID-19 vaccines against clinical disease, equity and uneven distribution of federal COVID-19 relief funds to US hospitals, and more.

**Nursing Home Advisory Group Town Hall:** Thank you to everyone who joined the Nursing Home Advisory Group Town Hall today. We had 120 participants and a lively discussion, both on air and in the chat. The discussion from today's Town Hall will help us shape our Policy Priorities for 2022 and inform our work at LeadingAge for the months and year ahead. The Nursing Home Advisory Group call is held

**Congressional Update.** This is a huge and consequential week in Congress. Build Back Better Act (reconciliation): The House Budget Committee stitched together all 2465 pages of the various bills marked up by Ways & Means, Energy & Commerce, Ed & Labor, Financial Services and more on Saturday but the Speaker has put off voting till Thursday because she, the White House and Senate majority leader Schumer are still negotiating within the Democratic Party for a bill that satisfies both the moderates that appear to want a smaller bill (not clear how this will affect our LTSS provisions) and the progressives that are happy with the current bill. Room for advocacy, as the bill is not final yet! Check out our Action Alerts [here](#). We are continuing to meet with Hill offices on Build Back Better, to keep the focus on the care infrastructure provisions important to the aging community.

**No Monthly Reporting Plans!!! (and other NHSN Reporting Updates):** We reported on the member update that the monthly reporting plan was required for nursing homes reporting vaccination data through NHSN beginning this week ending October 3. We later learned that thanks to our advocacy on your behalf, CDC has built in a work-around that will allow nursing homes to report **data without submitting a monthly reporting plan** through March 2022. Great news! All other changes to reporting are effective with this reporting week ending October 3. For more information on the changes to reporting, check out the Tables of Instructions [here](#).
