

Nursing Home Weekly: Recap of LeadingAge Updates

December 3, 2021

What are we learning about the Omicron variant? What are the new COVID treatments and do they work? And, how are large multistate providers implementing their corporate vaccine mandate for staff. New Action Alert! Senate Must Pass the Build Back Better Infrastructure Package and Take Out Harmful Nursing Home Provisions. As the Senate debates the historic expansions in housing, services, and workforce in the House-passed Build Back Better Act (H.R. 5376), we want to urge Senators to preserve these ground-breaking provisions and increase the funding for new construction of HUD Section 202 homes for low-income older people. However, to preserve maximum choice for older people and their families, there are two provisions in the bill related to nursing home staffing that LeadingAge cannot support without key changes. Retaining the nursing home staffing study and the 24 hour registered nurse coverage requirements as currently written will make it impossible for many nursing homes to survive. We need your help now! Without these changes and further investments in our aging services infrastructure, too many older adults will not have their basic needs met. CMS Issues Memo Related to Vaccine Mandate: CMS issued a memo Thursday afternoon acknowledging the court rulings from Missouri and Louisiana that prohibit CMS from implementing and enforcing the interim final rule in all 50 states and the District of Columbia and US Territories. CMS has appealed both court decisions and filed motions for stays of the orders but states, "while these preliminary injunctions are in effect, surveyors must not survey providers for compliance with the requirements of the Interim Final Rule." Provider Relief Fund Payment Updates: HRSA shared on a stakeholder's call that 43,759 providers qualified for American Rescue Plan (ARP) rural payments through the Provider Relief Fund and 90% of payments went to providers located in rural areas. 68% of the ARP rural payments went to acute care hospitals based upon the methodology for these payments compared to 11% to nursing homes. Payments were determined based upon analyzing Medicare and Medicaid claims data from January 1, 2019 through September 30, 2020 to determine the volume and type of services a provider delivered to rural beneficiaries. know what those payments in their bank account is for. HRSA also noted that they plan to start sending out Phase 4 PRF Payments in mid to late December.

Official CMS response to LeadingAge on Fire Safety Scoring Delay. We received a <u>response</u> to Katie Sloan's <u>letter to CMS</u> Administrator Chiquita Brooks-LaSure concerning the "mandatory values" scoring system for nursing homes. Moments before the previous delay ran out, CMS issued an <u>update to the waiver guidance</u> extending the deadline to November 1, 2023. We pushed that guidance out the day we received it. Yesterday's letter from the Administrator formally responds that the extension came out on October 20.

Nursing Home Advisory Group: The monthly Nursing Home Advisory Group call was held this past Tuesday with a whopping 200 participants! OSHA Extends Comments Period for the Vaccination and Testing ETS. The Occupational Safety and Health Administration on Wednesday issued a 45-day <u>extension</u> to the comment period for the COVID-19 vaccination and testing emergency temporary standard (ETS) for employers with 100 or more employees. OSHA says the deadline was pushed to Jan. 19, 2022, to allow stakeholders time to review the ETS and collect information and data necessary for comment. OSHA is currently prohibited from implementing and enforcing the ETS because a preliminary injunction is in place until we get a further decision from the 6th Circuit Court of Appeals.

CDC Update on First Omicron case in USA. This week CDC issued this <u>fact sheet</u> on the first confirmed case of the Omicron variant in the US. They included the following information along with the fact sheet: The recent emergence of the Omicron variant (B.1.1.529) further emphasizes the importance of

vaccination, boosters, and general prevention strategies needed to protect against COVID-19. Everyone 5 and older should get vaccinated and boosters are recommended for everyone 18 years and older.

CDC issued a <u>media statement</u> regarding this first confirmed case of Omicron variant detected in the United States earlier today. CDC will provide updates as more information becomes available. CMS to begin posting booster data reported to NHSN. On December 9, CMS will begin posting nursing home level booster data; CDC will post it at the state level.

New blanket waiver on directors of food and nutrition. CMS issued a new 1135 Blanket waiver on the requirements of a Director of Food and Nutrition Services, effective November. 26, 2021. The waiver allows more flexibility in the education and training requirements for individuals serving as Directors of Food and Nutrition Services.

Summaries of interviews in selected recent LeadingAge Coronavirus Update calls. Here are written summaries of some recent interviews on COVID Update Calls. CMS Stops Seriously III Part of the Primary Care First Model: CMS and CMMI have been reviewing the Seriously III Population component of the Primary Cares First (PCF) Model. This element presented an opportunity to target high-needs, seriously ill Medicare beneficiaries with more coordinated care and also engaged hospice and palliative care service providers. Here is a short <u>article</u> on today's announcement.

Capitol Hill Update. December will be a busy and consequential month – three big issues are pending and all are likely to be decided before the end of the year!

First up is appropriations. The Continuing Resolution (CR) that keeps the federal government open, and funds HUD, Older Americans Act, broadband and other non-Medicare/Medicaid programs expires Friday night. Since none of the agency appropriations bills have passed, expect another CR either through the end of this year or beginning of next to allow both sides to come to agreement on an "omnibus" appropriations bill to fund the rest of the fiscal year. Worst case scenario would be a CR through FY 2022, which would be based on funding from 2020.

Second is raising the debt ceiling – this is the arcane and artificial limit that the government can spend on already-appropriated funds. As with appropriations, there is bipartisan desire to address this but negotiations seem stalled and a December 15 deadline looming, so stay tuned.

Finally, the Build Back Better Act is now in the Senate, where it will likely undergo some changes, depending on negotiations within the Democratic caucus. Majority Leader Schumer has indicated a desire to vote by Christmas at which point the bill would go back to the House because of changes made to the House bill, and while it is possible that the House would vote before the end of the year, this is very ambitious and we will have to see. For our purposes, we

are using this time to advocate for increased funding for the HUD 202 program and changes to the nursing home staffing mandates (e.g., eliminating the mandates, providing funding, etc.). We have a new one-pager to share.

CDC/Hartford Foundation Stakeholder Webinars on "Strike Team" Program. The Hartford Foundation and CDC are planning two more stakeholder webinars on the nursing home/long-term care "strike team" program and funding. As was the case with webinar #1 all interested stakeholders are welcome to join and there will likely be recordings available soon after the events. Webinar #2 was held November 30 and webinar #3 is December 6 at 4:00 PM ET. On November 30, the topic was state based approaches to nursing home and other LTC facility support and on December 6 the focus is education-based programs to engage and expand the LTC workforce.
