



Home Health and Hospice Weekly: Recap of LeadingAge Updates

March 4, 2022

LeadingAge Coronavirus Call. New research evidence of a higher risk of heart attacks, strokes, and mental health issues after COVID. On **Monday, March 7 at 3:30 PM ET**, **Dr. Ziyad Al-Aly**, Director of the Clinical Epidemiology Center at Veterans Affairs St. Louis Health Care will talk about research from his center on the increased risk of cardiovascular and mental health issues up to a year after having COVID. He will talk about the importance of cardiovascular care post COVID infection in people of all ages, whether their COVID symptoms were mild or very severe. The cardiovascular research was published in Nature Medicine on February 7. He'll answer questions from callers and provide suggestions for aging services providers. Hospice VBID Request for Applications. Today, CMMI [announced](#) request for applications (RFAs) for the Value-Based Insurance Design Model Hospice Benefit Component. Medicare Advantage Organizations must apply to participate in the model by April 15, 2022. The announcement also includes CY 2023 preliminary hospice capitation payment rates [methodology](#) for CY2023.

Home Health Public Reporting Refresh Coming in April. In April 2022, publicly reported OASIS data will be released with two new measures in that align with the Improving Medicare Post-Acute Care Transformation (IMPACT) Act: 1) Percent of Residents Experiencing One or More Falls with Major Injury and 2) Application of Percent of Long-Term Care Hospital Patients with an Admission and Discharge Functional Assessment and a Care Plan that Addresses Function. While these two new OASIS measures will be reported, CMS made the decision to delay the resumption of claims-based quality measures in order to analyze the impact of the exclusion of Q1 and Q2 2020 claims data on risk adjustment and reporting. CMS is targeting July 2022 refresh of Care Compare for the claims-based measure updates. CMS updated the Home Health Quality Reporting Program COVID-19 Public Reporting [Tip Sheet](#).

Hospice Quality Reporting Program TEP Update. CMS released a [Summary Report](#) from the Hospice Quality Reported Program Technical Expert Panel (TEP). The report covers the conversations of the TEP a number of issues which will inform the development of the the Hospice Outcome & Patient Evaluation tool (HOPE) which will eventually replace the current Hospice Item Set (HIS). The TEP spent time looking at timely reassessment of symptoms as important to prioritize when considering future HOPE process measures. The TEP did not feel like many process measures currently available provided meaningful indicators of quality except for medication management, though the TEP felt individuals in inpatients facilities should be excluded from that measure. The TEP also expressed reservations about the usefulness of data from deficiencies and complaint surveys to determine hospice quality. Variation in surveyor process, regional data, and inconsistencies in deficiency citations over time all gave the TEP pause on pursuing future HOPE based on surveys.

Hospice Care Compare Refresh Now Available. The February 2022 quarterly Hospice Quality Reporting Program has gone live on [Care Compare](#). Data submission requirements were temporarily put on hold

after the November 2020 refresh. The Hospice CAHPS Survey measure scores continue to exclude Q1 and Q2 of calendar year 2020. As a reminder, in CY 2022 all hospices must meet the threshold requirements for HIS submission of 90% and participate in Hospice CAHPS to avoid a 4% reduction in their FY 2024 Annual Payment Update. This will be the first year of increased penalties from 2% to 4%.

New resources available from CDC on COVID-19 and infection control. [CDC's Project Firstline](#) offers resources to help frontline healthcare workers understand and confidently apply the infection control principles necessary to protect themselves, their families and their community. Webinar: Earned Income Tax Credit Information Now Available. New resources and information about the Earned Income Tax Credit (EITC) is now available on the [HUD Exchange](#). The 2021 American Rescue Plan (ARP) expanded the EITC to include more workers without children as well as older workers (65+), temporarily raised the maximum credit for individuals without dependents from approximately \$540 to \$1,500 and increased the income cap to qualify for individuals without dependents from approximately \$16,000 to \$21,000. The EITC is not considered income and receiving these tax credits will not impact anyone's eligibility for federal benefits. The federal government along with hundreds of non-profit organizations, state and local governments, and members of Congress are engaged in an all-out push to make sure every eligible American receives the EITC by filing their taxes. CMS Releases Medicaid "Unwinding" Resources. CMS issued new guidance to states about promoting continuing of coverage and distributing the eligibility and enrollment workload in the upcoming unwinding of Medicaid PHE related authorities. Biden Administration Releases New COVID-19 Preparedness Plan. The White House released a new [National COVID-19 Preparedness Plan](#). It is focused on 4 key goals: 1) Protect and treat against covid; 2) prepare for new variants; 3) prevent economic and educational shutdowns; and 4) continue to vaccinate the world. Each of the four goals has a number of specific tactics, both for the Administration to execute on its own and for them to work with Congress to achieve.

Interview with Dr. Michael Fine, author and former Director of Rhode Island Department of Health. [Here](#) is an article featuring some of the highlights from our interview with Dr. Michael Fine, Chief Health Strategist for the city of Central Falls, Rhode Island. Central Falls has the distinction of having both the most COVID and the least COVID at different points during the pandemic. He talked about his views on the new CDC recommendations and the tension between politics and public health, COVID and the aging services workforce, and myths related to Omicron. He further suggested that we have not figured out how to best use rapid testing and should be using it more.

West Health Institute Requesting Feedback on Telehealth. [West Health Institute](#), a nonprofit, nonpartisan applied medical research organization, is seeking to understand providers' barriers, goals, and experiences serving older adults via telehealth. They are working closely with subject matter experts from around the country to develop provider-focused principles, guidelines, and implementation strategies to support the use of telehealth with older adults. The results of this [10-minute survey](#) will be used in those efforts.

CMS stakeholder call on Medicaid RFI. CMS held a stakeholder call on the Medicaid and CHIP RFI on March 1. A lot of the questions were about logistics of submitting responses because CMS is using an online form rather than a traditional upload of a pdf to regulations.gov for these comments. Each question in the RFI has room for 20,000 words so there should be plenty of space for comments. If you need to use citations, one suggestion that came up was putting them in a google doc and embedding it in the form; there is no way to attach documents for this submission. Commentors do not have to answer all the questions, just the ones most pertinent to them. CMS asked for comments to be as specific and actionable as possible because they plan to utilize a range of tools to implement the suggestions, some of which may be faster than others.
