

Nursing Home Weekly: Recap of LeadingAge Updates

March 4, 2022

LeadingAge Coronavirus Call. New research evidence of a higher risk of heart attacks, strokes, and mental health issues after COVID. On Monday, March 7 at 3:30 PM ET, Dr. Ziyad Al-Aly, Director of the Clinical Epidemiology Center at Veterans Affairs St. Louis Health Care will talk about research from his center on the increased risk of cardiovascular and mental health issues up to a year after having COVID. He will talk about the importance of cardiovascular care post COVID infection in people of all ages, whether their COVID symptoms were mild or very severe. The cardiovascular research was published in Nature Medicine on February 7. He'll answer questions from callers and provide suggestions for aging services providers. New resources available from CDC on COVID-19 and infection control. CDC's Project Firstline offers resources to help frontline healthcare workers understand and confidently apply the infection control principles necessary to protect themselves, their families and their community. On March 14 from 3:00 – 4:00 PM ET CDC is hosting an event to introduce new infection control resources. Webinar: Earned Income Tax Credit Information Now Available. New resources and information about the Earned Income Tax Credit (EITC) is now available on the HUD Exchange. The 2021 American Rescue Plan (ARP) expanded the EITC to include more workers without children as well as older workers (65+), temporarily raised the maximum credit for individuals without dependents from approximately \$540 to \$1,500 and increased the income cap to qualify for individuals without dependents from approximately \$16,000 to \$21,000. The EITC is not considered income and receiving these tax credits will not impact anyone's eligibility for federal benefits. The federal government along with hundreds of non-profit organizations, state and local governments, and members of Congress are engaged in an all-out push to make sure every eligible American receives the EITC by filing their taxes. With just over one month left until the tax filing deadline of April 18, join HUD, Treasury, and the White House on Wednesday, March 9, 2022, from 2:00 PM – 2:45 PM for a webinar on the CTC and EITC.

CMS Releases Medicaid "Unwinding" Resources. CMS issued new guidance to states about promoting continuing of coverage and distributing the eligibility and enrollment workload in the upcoming unwinding of Medicaid PHE related authorities. Biden Administration Releases New COVID-19 Preparedness Plan. The White House released a new National COVID-19 Preparedness Plan. It is focused on 4 key goals: 1) Protect and treat against covid; 2) prepare for new variants; 3) prevent economic and educational shutdowns; and 4) continue to vaccinate the world. Each of the four goals has a number of specific tactics, both for the Administration to execute on its own and for them to work with Congress to achieve.

MACPAC Brief on State Strategies to Help with Nursing Facility Staff Shortages. the Medicaid and CHIP Payment and Access Commission (MACPAC) released a new <u>brief</u> on state policy levers to address nursing facility staffing shortages.

Interview with Dr. Michael Fine, author and former Director of Rhode Island Department of Health. Here is an article featuring some of the highlights from our interview with Dr. Michael Fine, Chief Health Strategist for the city of Central Falls, Rhode Island. Central Falls has the distinction of having both the most COVID and the least COVID at different points during the pandemic. He talked about his views on the new CDC recommendations and the tension between politics and public health, COVID and the aging services workforce, and myths related to Omicron. He further suggested that we have not figured out how to best use rapid testing and should be using it more.

West Health Institute Requesting Feedback on Telehealth. West Health Institute, a nonprofit, nonpartisan applied medical research organization, is seeking to understand providers' barriers, goals, and experiences serving older adults via telehealth. They are working closely with subject matter experts from around the country to develop provider-focused principles, guidelines, and implementation strategies to support the use of telehealth with older adults. Pennsylvania Medicaid Gap Study. LeadingAge Pennsylvania released a <u>report</u> this week showing the gap between Medicaid nursing home rates in the state and the actual cost of care. The gap is \$86.26 per resident day. The report was prepared by RKL and is explained in more detail in this <u>press release</u>.

Provider Relief Webinar Recording Now Available: HRSA has finally posted the <u>recording</u> of its Feb 17 webinar on Nursing Home Infection Control Provider Relief Reporting and the corresponding <u>slides</u>. The content is nearly identical to the Feb 2 webinar that HRSA presented for LeadingAge members. Just a friendly reminder that second period reporting, including the reporting on Nursing Home Infection Control funds, must be completed by 11:59 p.m. ET on March 31.

CMS stakeholder call on Medicaid RFI. CMS held a stakeholder call on the Medicaid and CHIP RFI on March 1. A lot of the questions were about logistics of submitting responses because CMS is using an online form rather than a traditional upload of a pdf to regulations.gov for these comments. Each question in the RFI has room for 20,000 words so there should be plenty of space for comments. If you need to use citations, one suggestion that came up was putting them in a google doc and embedding it in the form; there is no way to attach documents for this submission. Commentors do not have to answer all the questions, just the ones most pertinent to them. CMS asked for comments to be as specific and actionable as possible because they plan to utilize a range of tools to implement the suggestions, some of which may be faster than others. State of the Union Address included a nursing home quality focus. We learned in a meeting with CMS – and then it broke in the media – that President Biden would include a nursing home initiative in the State of the Union Address. We are pleased to see a focus on nursing homes (and aging services) in this important speech; however, the details matter. Here is Katie Smith Sloan's statement on the President's "FACT SHEET" on "Protecting Seniors and People with Disabilities by Improving Safety and Quality of Care in the Nation's Nursing Homes. Here is today's full White House Statement about the content of the State of the Union Address. (It's about halfway into the statement, under the title, "Protect Seniors and other nursing home residents by cracking down on unsafe nursing homes.") Additional elements of the speech will be important to aging services providers as well, such as a call for a \$15 an hour minimum wage, eliminating barriers to good paying jobs for all Americans, provisions about skills based apprenticeships, and paycheck fairness, among others.)

CMS has invited LeadingAge to work closely, along with other stakeholder organizations, in the implementation of the work. We have been assured that the first step, sometime this spring, will be a call for information from the field. We encourage members to work with us to develop the LeadingAge response and to submit their own input to CMS. The three primary components of the initiative, according to early information in our briefing and released to the media are:

- Staffing it sounds like CMS will conduct a year- long study on staffing ratios in nursing homes, which, CMS officials acknowledge, are not just a number; there are other important considerations. They expect to issue a proposed regulation (with a comment period) after that.
- **Special Focus Facilities** and increased funding for state survey agencies to identify "substandard" performing nursing homes.
- Ownership Transparency
