Free Protect Nursing Homes tool. We wanted to share with you a (free) new resource for nursing home/SNF leaders seeking to control infections at skilled nursing

facilities: ProtectNursingHomes.org. Built by Yale, UCLA and US Digital Response, the site provides rich detail on staff interconnectivity that has long been desired by nursing home administrators and health leads, but that has been difficult to attain. It can be a helpful tool in outbreak management for COVID as well as other infections that more routinely challenge nursing homes. FDA Authorizes Time for Refrigerator Storage of Thawed Pfizer-BioNTech COVID-19 Vaccine Prior to Dilution, Making Vaccine More Widely Available: Based on a review of recent data submitted by Pfizer Inc., the U.S. Food and Drug Administration is authorizing undiluted, thawed Pfizer-BioNTech COVID-19 Vaccine vials to be stored in the refrigerator at 2°C to 8°C (35°F to 46°F) for up to 1 month. Previously, thawed, undiluted vaccine vials could be stored in the refrigerator for up to 5 days. Pfizer Inc. submitted data to the FDA to demonstrate that undiluted, thawed vials of its COVID-19 vaccine are stable at refrigerator temperatures for up to 1 month. The updated Fact Sheet for Healthcare Providers Administering Vaccine (Vaccination Providers) is intended to help frontline workers understand the

Largest CDC COVID-19 Vaccine Effectiveness Study in Health Workers Shows mRNA Vaccines 94% Effective: On Friday, CDC put out a press release on the largest CDC COVID-19 vaccine effectiveness study in health workers, which shows mRNA vaccines to be 94% effective. The study was released as an MMWR, that examined the interim estimates of vaccine effectiveness of Pfizer-BioNTech and Moderna COVID-19 vaccines among health care personnel at 33 U.S. sites from January – March 2021. The first U.S. multisite test-negative design vaccine effectiveness study among HCP found a single dose of Pfizer-BioNTech or Moderna COVID-19 vaccines to be 82% effective against symptomatic COVID-19 and 2 doses to be 94% effective. The mRNA vaccines are highly effective at preventing symptomatic COVID-19 among U.S. HCP. This new CDC study adds to the growing body of real-world evidence (outside of a clinical trial setting) showing that COVID-19 mRNA vaccines authorized by the Food and Drug Administration (FDA) protect health care personnel (HCP) against COVID-19. This assessment, conducted in a different study network with a larger sample size from across a broader geographic area than in the clinical trials, independently confirms U.S. vaccine effectiveness findings among health care workers that were first reported March 29. Data for this assessment come from a network covering 500,000 HCP across 33 sites in 25 U.S. states, providing additional robust evidence that mRNA vaccines are effective against symptomatic illness in real-world conditions.

Hospice and COVID-19: HHS ASPR Technical Resources, Assistance Center, and Information Exchange (TRACIE) <u>released an interview discussing hospice during COVID-19</u>. For a profession whose mission is to help terminally ill patients plan their final days and guide them and their loved ones through the passage emotionally and spiritually, a global pandemic presented the ultimate challenge. ASPR TRACIE met with

Sarah McSpadden, RN, MSN, MHA, President and Chief Executive Officer of The Elizabeth Hospice, to learn more about her experiences during the COVID-19 pandemic.

Caregivers of People Living with Dementia: CDC updated their guidance for caregivers of people living with dementia. Given the risks that older adults face from both COVID-19 and dementia, CDC is providing this additional guidance to caregivers of adults with Alzheimer's disease and other types of dementia to reduce the spread of COVID-19 and to help them manage their patients' physical and mental wellbeing as well as their own wellbeing. Not all people living with dementia require caregivers. Therefore, the degree of assistance a person needs will depend on the extent that their dementia has progressed. For people living with dementia, changes in behavior or worsening symptoms of dementia should be evaluated because they can be an indication of worsening stress and anxiety as well as COVID-19 or other infections.

GAO Study on Nursing Homes and COVID. The Government Accountability Office (GAO), the auditing and evaluation arm of Congress, issued a report "COVID-19 in Nursing Homes: Most Homes Had Outbreaks and Weeks of Sustained Transmission from May 2020 through January 2021." The CARES Act directed GAO to monitor that federal pandemic response, including CMS's oversight of nursing homes in light of the pandemic (which was covered in prior GAO reports). In this report examining the frequency and duration of outbreaks, GAO found that only 64 nursing homes nationwide had no outbreaks and 44% had more than four outbreaks. Chairs of several key House committees issued a statement on the GAO report, noting the previous administration's "inadequate response to the pandemic placed our nation's nursing home residents in grave danger." They highlighted limited PPE and staffing shortages as a big part of the problem, and committed to work with the current administration to ensure that the federal government "better protects the American people, especially the most vulnerable.....from coronavirus and future public health emergencies."

Background on the Interim Final Rule. Holly Norelli from the Division of Nursing Homes at CMS joined Thursday's's call to talk a bit about the new Interim Final Rule and reporting requirements. As a licensed nursing home administrator who only recently moved to her position at CMS, her <u>perspectives</u> were helpful.

LTC Access for Middle Income Americans. The Long-Term Care Discussion Group's May meeting, set for May 25 from 1:00 – 2:00 PM ET, will focus on a new Milken Institute Report, "New Approaches to Long-Term Care Access for Middle-Income Americans." Speakers include Nora Super, Senior Director of the Milken Center for the Future of Aging, and report authors Jason Davis and Caroline Servat. Strengthening the Direct Care Workforce session coming up. Mathematica Policy Research's Center for Studying Disability Policy, will hold an event, "Strengthening the Direct Care Workforce: Scaling Up and Sustaining Strategies That Work" on Thursday, June 3, from 12:00 to 1:30 PM ET. The session will highlight state and local initiatives that scaled up evidence based recruitment, retention, training, and career advancement strategies, as well as discuss COVID-related adaptations. New Medicare and Telehealth Brief from KFF. The Kaiser Family Foundation released a brief today on "Medicare and Telehealth: Coverage and Use During the COVID-19 Pandemic and Options for the

<u>Future</u>." Nearly half (45%) said they had a telehealth visit between July and the fall of 2020. Over one in four of all community dwelling beneficiaries reported using telehealth during the same period. Of those who did use a telehealth visit, 56% used telephone only, while fewer used video. On that point, Katie Sloan coauthored an op-ed – "<u>Audio-Only Technology Can Bridge the Telehealth Divide</u>" - with Allyson Schwartz, CEO of the Better Medicare Alliance, on the importance of allowing and paying for audio-only telehealth visits. This is essential to promote and advance equity in access to telehealth services.

Provider Relief Fund FAQs: Here are a couple of tidbits members have been asking about. First, as it stands right now, providers have until June 30, 2021 to spend all Provider Relief Funds. In addition, we still do not know when HHS will require the first report to be submitted on provider's use of the Provider Relief Funds. HHS had said they would provide adequate notice prior to when reports will be due and will provide webinars and/or office hours to answer questions. In the meantime, members should make sure they have registered in the <u>reporting portal</u>. By doing this, they will receive communications from HHS once the reporting portal is open for report submission. Nicole has written a short <u>article</u> with this information for members.

Elder Justice legislation introduced in House. Legislation establishing a permanent Elder Justice Initiative in the Department of Justice will be marked up tomorrow by the House Judiciary Committee. The bipartisan Elder Abuse Protection Act of 2021 (H.R.2922), introduced April 30, creates the position of Elder Justice Coordinator to chair the initiative, which is authorized to coordinate and support DOJ's enforcement of elder justice, evaluating and disseminating model training materials for law enforcement and other personnel that come in contact with victims, covering such areas as how to appropriately respond to elder abuse, conduct investigations, and maintain online resources in both English and Spanish about elder justice.
