3. CMS Announces Hospice Outcomes & Patient Evaluation (HOPE) Beta Test Recruitment: CMS and their contractor, Abt Associates are now recruiting Medicare-certified hospice providers to participate in a beta test of the draft hospice patient assessment instrument called Hospice Outcomes & Patient Evaluation (HOPE). Recruitment ends June 14, 2021. Data collection is anticipated to begin in fall 2021. The detailed recruitment announcement and application for participation are available on CMS's <u>Hospice QRP Provider and</u> <u>Stakeholder Engagement</u> webpage.Those interested in participating should complete the application and email to <u>HospiceAssessment@CMS.hhs.gov</u> by June 14, 2021. 4. Resources for Compliance with Vaccine Reporting Rule: We have received several requests for resources to comply with the requirement in new interim final rule CMS-3414-IFC that nursing homes and ICF/IIDs must provide education on and offer the COVID-19 vaccine. These should be helpful to hospice and home health members who serve clients at nursing homes and also for inpatient hospices that must comply. - 7. Hospice and COVID-19: HHS ASPR Technical Resources, Assistance Center, and Information Exchange (TRACIE) released an interview discussing hospice during COVID-19. For a profession whose mission is to help terminally ill patients plan their final days and guide them and their loved ones through the passage emotionally and spiritually, a global pandemic presented the ultimate challenge. ASPR TRACIE met with Sarah McSpadden, RN, MSN, MHA, President and Chief Executive Officer of The Elizabeth Hospice, to learn more about her experiences during the COVID-19 pandemic.
- 8. Home Care and Hospice During COVID A Rural Perspective: HHS ASPR Technical Resources, Assistance Center, and Information Exchange (TRACIE) released an interview

discussing home care and hospice during COVID-19 from a rural perspective. In rural areas, home care and hospice often go hand in hand. Sue Heitkamp, RN, BSN, President, and Joelle Goldade, RN, BSN, CHPN, COS-C, HCS-D, Director of Clinical Operations (both of CHI Health at Home), shared how they carried out these important services during the COVID-19 pandemic.

- 9. Recap of Senate Finance Hearing on COVID-19 flexibilities available. An article on this week's Senate Finance hearing can be found <u>here</u>. The hearing was largely about telehealth but many of LeadingAge's priorities related to hospice, home health, HCBS, and PACE were discussed.
- 10. New Medicare and Telehealth Brief from KFF. The Kaiser Family Foundation released a brief today on "Medicare and Telehealth: Coverage and Use During the COVID-19 Pandemic and Options for the Future." Nearly half (45%) said they had a telehealth visit between July and the fall of 2020. Over one in four of all community dwelling beneficiaries reported using telehealth during the same period. Of those who did use a telehealth visit, 56% used telephone only, while fewer used video.

Katie Sloan coauthored an op-ed – "<u>Audio-Only Technology Can Bridge the Telehealth</u> <u>Divide</u>" - with Allyson Schwartz, CEO of the Better Medicare Alliance, on the importance of allowing and paying for audio-only telehealth visits. This is essential to promote and advance equity in access to telehealth services.

- 11. State by State Mask Mandates Tracking Available. Check out this new tracker on the LeadingAge website, showing mask mandates and related guidelines in each state, as of May 19. Following the CDC guidelines on masks, several States have modified their mask mandates to align with the federal guidelines while others have relaxed rules in most settings. Twenty state governments require people to wear face coverings in most indoor public settings to curb the spread of COVID-19. The District of Columbia and Puerto Rico also have mask orders in place. To date, 19 states that had mask orders covering the general public have mostly lifted them. Eleven states did not impose mask mandates at any point during the pandemic. We will update this tracker weekly.

- 13. LTC Access for Middle Income Americans. The Long-Term Care Discussion Group's May meeting, set for May 25 from 1:00 2:00 PM ET, will focus on a new Milken Institute Report, "<u>New Approaches to Long-Term Care Access for Middle-Income</u> <u>Americans</u>." Speakers include Nora Super, Senior Director of the Milken Center for the Future of Aging, and report authors Jason Davis and Caroline Servat. The session will highlight state and local initiatives that scaled up evidence based recruitment, retention, training, and career advancement strategies, as well as discuss COVID-related adaptations.
