**VOANS March 27 Health & Housing Symposium.** Volunteers of America National Services (VOANS) is hosting a 2022 Health & Housing Symposium on Sunday, March 27, 2:30 – 5:00 PM, followed by a networking reception from 5:00 – 6:00 PM. **HUD Withdraws Rent Comparability Studies Memo Limiting Services Valuations.** After strong pushback from LeadingAge and other housing stakeholders, HUD withdrew an earlier memo, dated November 15, that limited HUD support for services in Section 8 rent setting through the Rent Comparability Study

process. Without the March 24 withdrawal, the new HUD policy would have limited the agency's investment in non-shelter parts of Section 8 rents, including Service Coordination, meal services, transportation support, resident activities, and more. In a letter to HUD, LeadingAge had asked the agency to change course, citing the negative impact on project-based Section 8 communities serving older adults, and asked HUD to recommit to services and stakeholder engagement. In its March 24 withdrawal memo, HUD stated: "HUD expects to more fully address the issues that led to the release of this memo, as well as questions and concerns arising from the memo, in upcoming draft revisions to Chapter 9 of the Section 8 Renewal Policy Guidebook. These revisions will be available for public review and comment prior to taking effect." LeadingAge looks forward to working with our members to provide constructive feedback to HUD on improvements to Chapter 9 of the Renewal Guide when the agency initiates public review and comment. Home Appraisals, Bias, and Aging Services. Today, the White House's Interagency Task Force on Property Appraisal and Valuation Equity (PAVE) issued its action plan for home appraisal equity. Home appraisals directly impact household net wealth, which directly impacts older adults' ability to age with choice. Bias and discrimination in the home appraisal process are directly linked to equitable access to many aging services. An appraisal is a critical element of homebuying and lending processes as it establishes the value of the property as the collateral for a home loan. After retirement, the value of a homeowner's home is often its key source of wealth. This wealth can be used to fund the services and supports needed to age with choice and dignity. HUD Clarifies Property Expectations During Ramp UP of NSPIRE Demonstration Inspections. In an email communication to housing stakeholders, HUD clarified what NSPIRE demonstration properties can expect during upcoming inspections. HUD is on track to meet its phase two goal of 900 NSPIRE demonstration advisory inspections by the end of May, with many LeadingAge members getting scheduled for the next month. Under the NSPIRE demonstration, NSPIRE inspectors follow the same COVID-19 guidance as regular REAC inspectors, and properties should continue to report known COVID-19 cases. Aside from COVID-19 protocols, the inspections differ for NSPIRE participants, including in the inspection area, emphasis, and case management system. More information here.

Share of HUD-Assisted Older Adults Declines. A new report from HUD, Characteristics of HUD-Assisted Renters and Their Units in 2019, takes a deep dive into HUD households and their homes. Among the highlights from the new HUD report is that the share of HUD households who are 65+ decreased from 35% in 1989 to 30% in 2019. Also, the voucher program's share of units grew from 26% in 1989 to 48% in 2019, while shares of public housing and privately owned multifamily housing declined by 13 and 9 percentage points, respectively. And, the number of HUD-assisted rental units only increased by 11% between 1991 and 2019. During the same period, the total number of all very low income renter households in the U.S., who are generally eligible for HUD housing assistance, increased by 18%. Accessibility Needs of U.S. Households. Of all U.S. households, 19% include someone with accessibility needs, according to new research from HUD's Office of Policy Development & Research. These 23.1 million households include an individual who has a mobility-related disability, has difficulty accessing

their home or accessing and using spaces in their homes, or uses a device to assist with their mobility. However, the *Accessibility in Housing: Findings from the 2019 American Housing Survey* report found, these households largely live in homes that are not fully accessible. For example, about 4 in 10 U.S. households that include a person with accessibility needs do not currently have accessibility features such as ramps, lifts, or a bedroom and full bathroom on the entry level, which are features that they might need. In addition, a negligible share of owner households are planning to add features to make their homes more wheelchair accessible. Researchers, using the American Housing Survey, asked if the household includes someone who had difficulty entering their home, accessing or using the kitchen, accessing or using the bathroom, or accessing or using the bedroom because of a condition. Six percent of U.S. households, representing 6.9 million households, reported having at least one household member with one of these accessibility difficulties. Read the full report here.

Northeastern LeadingAge States To Host Regional HUD Call with Housing Members. LeadingAge state partners from the Northeast HUD Region are hosting their first regional collaboration call with HUD of 2022. The call will take place on April 6 from 2-3:30pm, with an agenda created by housing members from the area. The calls are interactive and give LeadingAge senior housing providers a chance to connect directly with regional HUD staff. Congressional Meeting Training Recording and Next Steps. We were thrilled with this week's turnout for the Leadership Summit Congressional Meeting training for LeadingAge members and staff with meetings scheduled for next week. Addressing the HCBS Workforce Challenges. This week, the Medicaid and CHIP Payment and Access Commission (MACPAC) released an issue brief, "State Efforts to Address Medicaid Home and Community Based Services Workforce Shortages." The brief looks at state Medicaid levers to address the HCBS workforce shortage, noting that low wages, high rates of turnover, and lack of advancement opportunities all contribute to the shortage. In turn the shortage of workers limits the ability of state Medicaid programs to provide adequate services to beneficiaries in the community. Among other things, the issue brief provides examples of state actions using funds provided under the American Rescue Plan Act to support the HCBS workforce. Nearly all states who have applied for ARPA funds include some type of HCBS workforce efforts in their plans.

**HCBS Reduces Costs for Families and States.** A new <u>policy brief</u> from the Brandeis Community Living Policy Center looks at how increased access to and investments in home- and community-based services have positive economic impacts on families, the HCBS workforce, and states.

**Interview with Katelyn Jetelina.** On today's update call, we spoke with Katelyn Jetelina, "Your Local Epidemiologist." Here's an article covering some of her commentary. She strongly urged everyone in the general community to monitor transmission levels in their own communities. She said if they are below 50 cases per 100,000 people, "you can relax a bit." If they go above 50, it's time to take more precautions in the community, like wearing masks.

Senate Special Committee on Aging Discusses Importance of Home-Based Services. The Senate Special Committee on Aging held a hearing to address, "An Economy That Cares: The Importance of Home-Based Services." The Aging Committee hearing is part of the renewed momentum for Congress to pass an economic package in late-April that helps families and workers manage high cost, and helps people cope with increased prices. Advisory Committee Looks at Seniors and Disaster Relief. Next Wednesday, March 30 from 1:00 - 3:30 PM ET the Assistant Secretary for Preparedness and Response and the Assistant Secretary for Aging and Acting Administrator for Community Living will <a href="https://docs.org/living.com/host">host</a> the joint inaugural meeting of the National Advisory Committee on Seniors and Disasters (NACSD) and National Advisory Committee on Individuals with Disabilities and Disasters (NACIDD). These committees are tasked with evaluating issues and programs and providing recommendations to the Secretary of Health and Human services on how to support and enhance all-hazards public health and medical preparedness, response, and recovery activities to meet the unique needs of older adults' and individuals with disabilities.

**Social Security Offices Reopen for In Person Business.** The Social Security Administration (SSA) held a virtual meeting with aging services providers on their re-opening plans today. They announced that they will start transitioning remote employees back to the office on March 30. In early April they will start inperson appointments and offers in-person services for people without an appointment. They are encourgaging people who can access their services online or by phone that they continue to do business online or by phone and schedule an appointment, when possible, which will better allow SSA to timely serve people who cannot use those options. They are also asking people to review "Know Before you Go", a checklist of points to keep in mind before visiting their offices.

**OAA Senior Nutrition Programs Celebrate 50 Years.** Health and Human Services Secretary Xavier Becerra <u>celebrated</u> the 50<sup>th</sup> anniversary of the Older American Act's Senior Nutrition Program. Since 1972, has provided funds to local ageinces and organizations to help older adults' access healthy meals and remain independent, well and connected to their communities. Each day these 5,000 programs provide 1 million meals to older adults' across the country. These programs do more than just provide meals, they provide nutrition screenings, education and counseling as well as social connections that many seniors lack on a daily basis.
