

**Service Coordinator in Multifamily Housing Program and
Congregate Housing Services Program**

**Coronavirus Aid, Relief, and Economic Security
(CARES) Act**

Program Instructions

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (P.L. 116-136) provides \$50 million in the *Housing for the Elderly* Account to prevent, prepare for, and respond to coronavirus, including to maintain normal operations and take other necessary actions during the period that the program is impacted by coronavirus. Of this total, up to \$10 million in CARES Act funding is for service coordination and continuation of congregate housing services grants. Funds under the \$10 million set-aside will be allocated as amendments to existing grantees under two distinct supportive services programs: 1) [Service Coordinators in Multifamily Housing \(SCMF\)](#) and 2) the [Congregate Housing Services Program \(CHSP\)](#).

The [Service Coordinator in Multifamily \(SCMF\) Program](#) provides funding for the employment of service coordinators in insured and assisted Multifamily Housing designed for the elderly and persons with disabilities. A service coordinator is a social service staff person hired or contracted by the Owner or management company. The service coordinator plays a critical role in supporting HUD-assisted multifamily housing as a platform for financial security, physical security, social connections, and the delivery of long-term community based supportive services. Currently, the Department provides funding for the annual renewal of approximately 1,600 on-going grants (initially awarded through a NOFA competition).

The [Congregate Housing Services Program \(CHSP\)](#) offers grants to States, units of general local government, public housing authorities, tribally designated housing entities, and local nonprofit housing sponsors to provide at least one hot meal a day and other supportive services necessary for independent living by frail elderly residents and residents with disabilities in federally subsidized housing. Currently, the Department provides annual funding for the renewal of approximately 30 grants (initially awarded through a NOFA competition).

During the coronavirus pandemic, HUD-assisted multifamily housing providers are facing unprecedented challenges in the delivery of services and supports to vulnerable residents. Demands on existing service coordination and congregate housing services programs are increasing as communities respond to COVID-19. The SCMF and the CHSP programs are critically important during this time and must adapt to changes in circumstances. Risk factors for experiencing severe COVID-19 symptoms, which include being 65 years of age or older or having serious underlying medical conditions,¹ and stay-at-home orders and social distancing guidelines have challenged providers to replace congregate activities and face-to-face interactions with different methods of communicating and delivering meals and other supportive services to older adult residents. Preventing the spread of the virus and protecting service coordinators and residents has meant purchasing equipment and supplies beyond the typical project inventory. CARES Act supplemental funding will provide a critical infusion of funds to address increased salary costs and related grantee needs during the time period that properties assisted by the two programs are impacted by the virus.

I. ELIGIBLE HOUSING PROJECTS.

A project must be a recipient of a SCMF or CHSP grant in CY 2020 to receive CARES Act supplemental funding. CARES Act supplemental awards are provided for each grant.

II. GRANT AMOUNTS.

Each active SCMF and CHSP grant that has been extended for 2020 will be eligible for a one-time supplement of CARES Act funding in an amount that is directly proportionate to the 2020 approved grantee budget approved by HUD. The supplemental awards will be equivalent to **9 percent** of their SCMF/CHSP program operating budget.

III. PROGRAM REQUIREMENTS.

- A. Availability and Non-Renewal of Funding.** Increased grantee expenditures must support program activities during the period that the properties served by grantees are impacted by COVID-19, which is identified in this case as the period between March 27, 2020, through December 31, 2020. The Department currently anticipates that funds not drawn down by the grantee in eLOCCS by January 31, 2021, will be recaptured by HUD and unavailable for 2021 grant program activities. This one-time funding under the CARES Act is not renewable.
- B. Application Deadline.** To be considered for CARES Act supplemental funding, SCMF and CHSP grantees must apply for the amendment by completing the SF-424 Application for Federal Assistance. Deadline for grantees to submit the SF-424 is September 11, 2020. See Submission Requirement for detailed instructions.
- C. Acceptance of Notice of Award.** Once the internal HUD funding process is complete, the grants specialist will prepare a Notice of Award within GrantSolutions for acceptance by the grantee. The grantee will have **5 business days** to respond. Should a grantee not anticipate eligible cost increases and determine to decline the supplemental funds, or should a grantee not accept within the allotted time, amounts will be recaptured and reallocated for other CARES Act purposes.
- D. Eligible Expenses.** Grantees will be allowed to use the CARES Act supplemental funds to increase the existing funding allocations for certain budget line items (BLIs). Grantees will be required to provide a spending plan document to reflect intended use of the supplemental funds. This submission will be used by Multifamily field office staff to spread funds in eLOCCS prior to any disbursement of any CARES Act funds. Please see Sections IV and V, and Appendix A for more information about the spending plan and eligible expenses.
- E. Ineligible Expenses.** In addition to the normal restrictions under the SCMF and CHSP, funds may not be used for certain expenses. Please see Appendix A for more information.
- F. Budget Line Items Thresholds.** The dollar thresholds for the BLIs for training, travel, and supplies/materials established under the traditional MFSC and CHSP grants do not apply to

the CARES Act funds. All budget requests will be reviewed on a case-by-case basis and must be supported by a written justification.

- G. Governing Requirements.** Recipients of grant funds are responsible for meeting program requirements set forth in these instructions, the specific Notices of Funding Availability (NOFA) under which they were initially funded, governing statutes, regulations, grant agreements, and the Management Agent Handbook, 4381.5, REV-2, CHG-2, Chapter 8. Failure to comply will be a basis for denial of any additional grant funds.
- H. Reserve for Replacement Accounts.** In the event of any funding delays, Owners may access available Reserve for Replacement funds. If Owners/Management Agents borrow funds from other project accounts to cover expenses while awaiting CARES Act funds, those other accounts must be fully reimbursed with grant funds immediately upon the availability and access to the grant award.
- I. DUNS Number.** All Owners MUST maintain an active DUNS number. An active DUNS is required before funds can be disbursed to the grantee. The DUNS is the nine-digit identification number assigned to a business or organization by Dun & Bradstreet and provides a means of identifying business entities on a location-specific basis. The DUNS number must be provided on all financial/banking documents sent to HUD. If the DUNS number is not included on such documents, HUD will not process the action(s). NOTE: DUNS Number tied to a property management entity is not allowable. The DUNS Number must be that of the Ownership entity. Prior to time of award, please make certain that the DUNS number that you have provided to HUD is that of the Ownership entity. SAM.gov information must be consistent with the information provided on the SF-424. Application for Federal Assistance form. If such is not the case, please connect with your local grants specialist.

- J. Drawdowns.** Grantees must draw down funds on the same basis as chosen by the grantee in GrantSolutions Grant Notes for the CY2020 grant funds, on a monthly or quarterly basis only. No other frequency will be allowed.
- K. Financial Reporting.** Incremental cost increases associated with the SCMF and CHSP program preparation and response to COVID-19 must be distinctly identified in grantee financial records and reported in the semi-annual expense reports (HUD 50080-SCMF and the SF-425 [CHSP]). On the HUD 50080-SCMF, grantees must provide a budget line item (BLI) breakdown, including the expense amounts association with the use of CARES Act funds. Similarly, for the SF-425(CHSP), grantees must submit an attachment that lists the CARES Act expenses by BLI.

Corrective actions for any identified non-compliance will be implemented consistent with terms of the existing grant agreements and SCMF/CHSP program guidance.

- L. **Record Retention.** Financial records, supporting documents, statistical records, and all other non-Federal entity records pertinent to a Federal award must be retained for a period of three years from the date of submission of the final expenditure report or, for Federal awards that are renewed annually, from the date of the submission of the last semi-annual financial report, respectively, as reported to the Federal awarding agency [[2 CFR §200.333](#)]. The records are subject to audit by HUD. **See Vouchering for more information about supporting documentation.**

IV. SUBMISSION REQUIREMENT.

- A. **Existing GrantSolutions Accounts.** To be considered for CARES Act award, grantees MUST Access GrantSolutions, apply for the Announcement, and complete the Online SF-424. The SF-424 Application for Federal Assistance form must be completed with the owner entity information. The information must be identical to that of System for Award Management (SAM). Below are specific instructions for certain fields contained within the SF-424:
- Type of Submission (1). Please check “Application”
 - Type of Application (2). Please check “New”
 - Federal Award Identifier (5b). Please insert your original Grant Number
 - Applicant Information (8). Input Owner Information ONLY. *Legal Name, *Employer/Taxpayer/Identification Number (EIN/TIN) and *DUNS (please verify this listed information is correct, if the information is not correct reach out to the assigned Grant Specialist)
 - Congressional Districts Of (16). Input based on property location. For more information visit: <https://www.census.gov/mycd/> and/or <https://www.govtrack.us/congress/members/map>
 - Proposed Project (17). “Start Date” Enter 03/27/2020. “End Date” – Enter 12/31/2020
 - Estimated Funding (18 a. Federal). Enter amount for the organization listed in “**CARES Act for SC and CHSP Funding Allocation Amounts**” spreadsheet (the attached spreadsheet has the maximum amounts that each organization can applied for under this opportunity).
 - Is the application Subject to Review by State Under Executive Order 12372 Process? (19). This supplemental funding is not subject to Executive Order 12372. This requirement was satisfied at time of initial submission. Select “c.”
 - Is the Applicant Delinquent on any Federal Debt? (20). Select “No”, if it “Yes” then an explanation is required along with the application as to what the Delinquent Federal Debt is, and steps being made to resolve the issue.
 - Authorized Representative (21). Select “Agree”
- B. **Ownership Change.** If previously funded grantees recently had a change in ownership, new owners must be eligible for the CARES Act award based on established requirements before the new owner can directly receive grant funds. HUD must approve owner change and the owner must submit a completed form HUD-1044-C to the Grants Specialist.
- C. **New to GrantSolutions.** All Grantees that are new to GrantSolutions MUST:

- Contact your local Grants Specialist
 - Register as a new applicant in GrantSolutions by submitting the Grantee User Account Request Forms. Email all required documents to the GrantSolutions Help Desk at help@grantsolutions.gov. Be certain to copy your local Grants Specialist and Dorthera.Yorshire@hud.gov.
- D. Once GrantSolutions access credentials are received, grantees are required to complete the Online SF-424. The SF-424 Application for Federal Assistance form must be completed with the owner entity information. The information must be identical that of System of Award Management (SAM). Please see the instructions on how to complete the Online SF-424 above in “Existing GrantSolutions Accounts.”
- E. **Spending Plan.** The grantee is required to submit the amount of the grant award to be allocated to each BLI and a detailed list of expenses and/or planned expenses of the CARES Act award. Grantees will complete one spending plan per CARES Act award. (A property with two MFSC and/or CHSP grants may receive more than one CARES Act award.) The HUD grants specialist will provide the grantees with a spending plan template and additional instructions. Use of the template is optional for grantees but will support faster processing of awards. The spending plan document must be submitted via Grant Notes/Application Notes in GrantSolutions. **See also Appendix A.**

V. SUBMISSION PERIOD.

Grantees MUST access GrantSolutions and submit the required information.

More specifically, upon receipt of GrantSolutions notification, the authorizing official must access the system and accept the award no later than **5 business days after receipt of notification** (see Section VIII.A, “Award Acceptance”). If the grantee does not respond, the funds will be recaptured by HUD.

Grantees must submit a spending plan via Grant Notes/Application Notes to the assigned grants specialist within **20 business days after acceptance of the award**. Should a grantee anticipate program cost increases for COVID-19 preparation and response that are less than the CARES Act supplemental grant amounts, the grantee must indicate this unallocated amount of CARES funds on the spending plan. Any portion of CARES grant funds not allocated in the spending plan for eligible costs will be immediately recaptured by HUD. See Appendix A for spending plan instructions and eligible expenses.

Please do not wait until the deadline date to respond to the grants specialist your information.

If a grantee has not received a CARES Act award because of reasons outside of their control, the Department will address such matter on a case-by-case basis and allow for disbursement once such matter has been resolved.

VI. DOCUMENTATION REVIEW AND CORRECTIONS

- A. **Reasonableness.** HUD will review the spending plan submission for eligibility and reasonableness and reserves the right to reduce the grant amount or request a revised spending

plan. In accordance with [2 CFR §200.404](#), a cost is reasonable if, in its nature and amount, it does not exceed that which would be incurred by a prudent person under the circumstances prevailing at the time the decision was made to incur the cost.

- B. Corrections to Spending Plan.** The HUD grants specialist may contact a grantee to clarify an item in the spending plan. HUD will exercise the authority for curing deficiencies, if needed, on a consistent and uniform basis for all grantees. Additionally, HUD reserves the right to respond to unanticipated system defects, research needs, ambiguities, and technical difficulties in grantee spending plan submissions through a flexible implementation of its authority to cure application deficiencies.

All grantees will have 14 days after date of notification to cure an identified deficiency in the spending plan. If the grantee fails to cure the deficiency, HUD reserves the right to withhold the grant award. The start of the cure period will be the date of the email from HUD. If the deficiency cure deadline date falls on a Saturday, Sunday, Federal holiday, or other day when HUD's Headquarters offices in Washington, DC, are closed, then the grantee's correction must be received on the next business day that HUD Headquarters offices in Washington, DC are open.

When HUD identifies a spending plan deficiency, HUD will notify the grantee describing the deficiency. Email notifications will be sent from HUD with confirmation of delivery receipt requested. The email notifications are the official notification of the need to cure a deficiency. The grantee must carefully review the request for cure of a deficiency and must provide the response in accordance with the instructions contained in the deficiency notification.

- C. CARES Act Spending Plan Revisions.** Any spending plan revisions after approval must be in accordance with 2 CFR Part §200.308. Outside of circumstances beyond the grantees control, the practice of redistributing funds throughout the performance period must be avoided. A request for budget line item redistribution, along with a justification, must be made by the authorized entity (or designee) and uploaded to GrantSolutions via Grant Notes. HUD will not accept any requests for budget revisions from a third-party entity. The owner's Authorized Official or the management agent, if authorized to execute the Notice of Award (NOA) on behalf of the Owner, must request the spending plan revision.

VII. MANAGEMENT OF GRANT FUNDS

- A. Award Acceptance.** Upon receipt of GrantSolutions notification, the authorizing official must access the system and accept the award no later than **5 business days after receipt of notification**.

The authorizing official must be the individual that has the authority to execute a legal document on behalf of the Owner. If the management agent has such authority and provides evidence to HUD, then that individual may serve as the authorizing official and may accept the award on behalf of the Owner.

IMPORTANT HIGHLIGHT: Each Grant has a unique GrantSolutions User ID and Password for the authorizing official. Please be sure that when you access the system to accept the award that the correct User ID and Password are being entered. If a recipient fails to accept the award within the desired timeframe, HUD may withdraw the offer.

- B. Availability of Funds.** No grant funds will be made available until the authorizing official has accepted and submitted the Notice of Award (NOA) via GrantSolutions and submitted the spending plan to the assigned grants specialist. Once the spending plan is approved by the grants specialist, the funds will be available within **3 business days**.
- C. Reimbursement** is the preferred method under this program. Grantee shall enter reimbursement requests on a monthly or quarterly basis through the eLOCCS system.

In accordance with the Prompt Payment Act, HUD must make payment within (30) calendar days after receipt of the reimbursement request through eLOCCS, unless HUD reasonably believes the request to be improper. For the latest guidance regarding payment methods, please see [2 CFR 200.305](#).

Grantee shall minimize the time elapsing between the transfer of funds from HUD (based on reimbursement request) and the disbursement of funds to vendors for program purposes. The maximum time between HUD transfer of funds and grantee disbursement of funds shall not exceed seven (7) calendar days after receipt of funds.

- D. The [Improper Payments Elimination and Recovery Improvement Act of 2012](#) (IPERIA).** IPERIA requires that each agency review prepayment and pre-award procedures and ensure that a thorough review of available databases with relevant information on eligibility occurs to determine program or award eligibility and prevent improper payments before the release of any Federal funds. This Act also establishes a [Do Not Pay Initiative](#) that requires all awards of Federal funds to be prescreened prior to award, as well as during the pre-payment and post-payment processes in order to prevent improper payments.
- E. Recapture of CARES Act Supplemental Funding.** The Department currently anticipates that funds not drawn down by the grantee in eLOCCS by January 31, 2021, will be recaptured by HUD and unavailable for 2021 grant program activities. Should a grantee not anticipate eligible cost increases and determine to decline the supplemental funds, or should a grantee not accept within the allotted time, amounts will be recaptured and reallocated for other CARES Act purposes.

Other criteria that will cause funds to be recaptured at any time include the following:

1. The grantee no longer wishes to spend CARES Act funds and alerts the grants specialist.
2. Grantee fails to comply with reporting requirements.

3. Non-responsiveness of the grantee.
4. If an owner's eligibility status changes during the course of period of performance of the CARES Act funding, making the owner ineligible to receive SCMF/CHSP funding, HUD has the right to recapture the CARES Act funds and terminate the existing SCMF/CHSP award. A change in eligibility status may be due to prepayment of the mortgage, sale of the property or opting out of an assistance contract. Owners are encouraged to communicate with their assigned grants specialist to minimize any interruptions to future grant funding.

HUD staff must notify the grantee of HUD's intention to recapture CARES Act funds.

VIII. VOUCHERING.

- A. **Timely Vouchering.** HUD requires that grantees use the eLOCCS system to draw down funds on a monthly or quarterly basis. Each draw down from eLOCCS must be used to cover expenses through the end of the previous month. Failure to do this may impact future extension funding amounts. Grantees must drawdown funds based on the requirements established. Timely drawdowns help ensure program compliance.
- B. **Reporting Period.** Upon completion of each drawdown in eLOCCS, grantees must access GrantSolutions and input the voucher number, the reporting period start date and the reporting period end date in Grant Notes. This data will be used to track timely vouchering compliance.
- C. **Supporting Documentation Requirements.** Grantees are required to maintain detailed expense documentation in their files. All vouchers must be supported by basic payment documents, either hard copy or soft copy source records, which include purchase orders, contracts, receiving reports, invoices, bills, statements of accounts, etc., showing sufficient information to adequately account for the disbursements. HUD will *randomly* review monthly/quarterly voucher to ensure compliance and reserve the right to request documentation as deemed necessary. Please do not submit supporting documents to HUD unless requested.
- D. **End of Fiscal Year Closeout.** HUD's accounting systems are typically closed during the first two to three weeks of October. During this time, no funds may be disbursed. To avoid any reimbursement delays, grantees are encouraged to submit vouchers no later than the end of the first week of September. This will allow for sufficient time for the grants specialists to process any manual vouchers or for the system to approve any automatic payments. If vouchers are not paid prior to the annual cut-off date, grantees must wait until the systems reopen before any payments can be made.

- B. Post award changes to existing and established GrantSolutions role(s).** To add, change, or closeout a user role in GrantSolutions, grantees must:
1. Complete the [Grantee User Account Request Form](#)
 2. Email the completed form to help@grantsolutions.gov. Be certain to copy your local grants specialist and Dorthera.Yorkshire@hud.gov. GrantSolutions will respond to your request within 48 hours.
 3. If there is a change in the Authorizing Official, please submit an updated Authorized Signature letter. The letter must be on the owner's letterhead, signed and dated by an authorized representative of the owner which authorizes the new Authorized Official to sign legal grant documents on behalf of the owner. Third-Party entities are not allowed to sign legal grant document on behalf of the owner. Submit the letter in Grant Notes.

APPENDIX A. SPENDING PLAN INSTRUCTIONS

A. Instructions

1. Following acceptance of the Notice of Award, grantees will develop a spending plan in accordance with the eligible expenses instructions in Table 1 and Table 2 below.
2. For each BLI, the grantee will provide the proposed expenditure amount and a description of the expenses. *The grants specialist can provide a template that is optional for grantees. Use of the template is encouraged to facilitate the processing of awards.*
3. If the grantee does not expect to incur expenses related to preparation and response to COVID-19 that utilize the full grant amount, the grantee will indicate the amount of remaining funds in the spending plan. These funds will be recaptured by HUD at a later date.

Spending Plan Instructions

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (P.L. 116-136) provides \$50 million in the *Housing for the Elderly* Account to prevent, prepare for, and respond to coronavirus, including to maintain normal operations and take other necessary actions during the period that the program is impacted by coronavirus. Of this total, up to \$10 million in CARES Act funding is for service coordination and continuation of congregate housing services grants. Funds under the \$10 million set-aside will be allocated to existing grantees under two distinct supportive services programs: 1) Service Coordinators in Multifamily Housing (SCMF) and 2) the Congregate Housing Services Program (CHSP).

Spending Plan Review and Approval. The grantee is required to submit the amount of the grant award to be allocated to each BLI and a detailed list of expenses and/or planned expenses of the CARES Act award within **20 business days** after acceptance of the award. The grants specialist will review the submission for compliance with program requirements (see Program Instructions for Documentation Review and Corrections procedures and deadlines). Once approved, this submission will be used by the grants specialist to spread funds in eLOCCS prior to any disbursement of any CARES Act funds.

Spending Plan. Please read Program Instructions before completing the spending plan. Grantees must complete one spending plan per CARES Act award. (A property with two MFSC and/or CHSP grants may receive more than one CARES Act award.)

Grantees are encouraged to use a spending plan template provided by the Grants Specialist. The spending plan template is a fillable PDF. Use of the template is optional for grantees but will support faster processing of awards. There are different spending plan templates for the SCMF and CHSP programs, each reflecting the budget line items (BLIs) of the specific program.

Required Information.

A. General Information

Ensure that you are using the correct form for SCMP or CHSP grants.

Fill in the following fields: Property Name, Existing Grant Number, CARES Act Grant Number, Property IREMS Number (9 digits), CARES Act Award Amount provided by HUD, and Grants Specialist Name.

NOTE: In the spending plan template, this information is requested in the upper part of the form.

B. Award Allocation Amounts

For each Budget Line Item (BLI) where the program anticipates requesting reimbursement for expenses due to COVID-19 preparation and response, provide the dollar amount to be allocated from the award.

Should a grantee anticipate program cost increases that are less than the CARES Act supplemental award, the grantee must provide this unallocated amount in the “Recapture” field. Any portion of CARES grant funds not allocated in the spending plan for eligible costs will be immediately recaptured by HUD.

The allocated and recapture amounts in the spending plan must total the CARES Act award amount.

NOTE: In the spending plan template, this information is requested in the lower part of the form in Column B titled “Allocation Amount.” The unallocated amount is required in the row titled “Recapture.” The row titled “Total” is a calculated field summing the Subtotal (also a calculated field) and recapture amounts entered in Column B. That figure must match the amount entered in the field titled “CARES Act Award Amount” in the upper part of the form.
