A.G. Rhodes Health & Rehab



Deke Cateau is the Chief Executive Officer at A.G. Rhodes Health & Rehab, a nonprofit organization providing therapy and rehabilitation services, short-term recovery and long-term care at three metro Atlanta locations. Cateau is responsible for an operating budget of approximately \$40 million and approximately 600 employees. A.G. Rhodes can accommodate more than 400 residents and patients, and serves more than 1,100 elders each year. Cateau has worked in the long-term care industry for more than 15 years. Prior to becoming the CEO, he served in various roles at A.G. Rhodes including the Chief Operating Officer, Chief of Strategic Implementation, and he was the

Administrator for seven years at the organization's flagship location in Grant Park.

Before working at A.G. Rhodes, Cateau worked at Five Star Quality Care, Inc., a national senior living communities and services provider. He served in many capacities including Area Operations Manager for Georgia, where he oversaw three skilled nursing facilities, eight assisted living facilities and one continuing care retirement community. In addition to running nursing facilities in metro Atlanta, Cateau has also managed a 200-unit continuing care retirement community in Savannah.

Dorothy Davis, LPCPresident & Chief Executive Officer

Visiting Nurse Health System, Inc.



Dorothy Davis is President & CEO of <u>Visiting Nurse Health System, Inc.</u>, a \$60+ million nonprofit organization providing home healthcare, community care, and end-of-life hospice services to more than 7,000 patients and clients each day throughout greater Atlanta. Visiting Nurse employs approximately 750 professionals. She formerly served as the Vice President of Community Health and Strategy for Visiting Nurse Health System.

In her role as VP of Community Health and Strategy, Dorothy worked with division executives on various strategic and operational initiatives. As VP, Dorothy played a key role in driving ancillary revenue across multiple key areas, strategic planning, and new business initiatives. Tasks included investigating value propositions associated with introducing new services to markets, and expanding into new markets. The VP defines objectives to gain market share and maximize profitability and executes plans to make those objectives achievable. Partnering with leaders across the organization, the VP's responsibility is to take advantage of the company's core competencies, and to recognize when strategies under consideration do not align with those competencies. Scope included the day-to-day operational responsibility of the Community Care and Innovative Aging divisions which includes two Georgia Medicaid waiver programs for the aged, blind, and disabled, Alzheimer's & Parkinson's respite care, health and wellness coaching, and case management for two county-based systems.
