PACE Organization Update

What's on Congress's Agenda: Based on conversations with key Senate and House leadership staff, LeadingAge has developed an article that provides an outlook for upcoming Congressional action on "What's on Congress's Agenda." We highlight: the CMS/HHS nominations; President Joe Biden's Joint Session; The American Jobs Plan - infrastructure process; the President's FY22 Budget Request; and the timing of immigration reform legislation. Update on PACE Legislation: In addition, we continue to work in support of two PACE bills working their way through Congress. On April 19, a letter signed by a coalition including LeadingAge sent a letter of support to the telehealth bill sponsors, citing specifically the importance of the bill for PACE organizations. We also began socializing the PACE Plus Act to Hill offices following its introduction late last week. LeadingAge Virtual Lobby Day Wrap Up: Thank you to everyone who helped make our Virtual Lobby Day a huge success. We had 442 members participate in 298 meetings with U.S. House and Senate offices. The feedback has been very positive from those attending meetings. Advocates received an email thanking them for participating and reminding them to fill out the report form and to follow up with their congressional offices. Our goal is for this to be the start of a relationship with the congressional offices.

Johnson and Johnson Vaccine Update: Late on April 23, the CDC vaccine advisory panel recommended the Johnson & Johnson vaccine for those 18+ again, following the pause on April 13. The pause is not yet lifted, but the CDC's endorsement is a step toward resuming administering this vaccine. The CDC panel considered but did not vote on whether to include a warning for women ages 18-50 related to potential clotting risks. The FDA is meeting soon to consider its own recommendations as well. We are reviewing the CDC panel's decision and other administration activity (like FDA) and will provide a more detailed update next week as we learn more- stay tuned. Alternative infrastructure plan: A group of Senate Republicans led by Sen. Shelley Moore Capito (RW.Va.) on Thursday unveiled a \$568 billion infrastructure proposal, a much smaller counteroffer to President Biden's \$2.3 trillion American Jobs Plan. The proposal seeks to define infrastructure more narrowly than the American Jobs Plan, focusing on roads and bridges, public transit systems, rail, wastewater infrastructure, airports and broadband infrastructure. Notably for PACE members, the proposal does not include anything about the \$400B HCBS proposal in the American Jobs Plan. LeadingAge continues to advocate that the aging infrastructure is part of the American infrastructure. There will be many more proposals and trade-offs; this conversation on infrastructure is just getting underway.

ARP Tax Credits Available to Small Employers to Provide Paid Leave to Employees Receiving COVID-19 Vaccines: President Biden is calling on <u>every employer</u> in America to offer full pay to their employees for any time off needed to get vaccinated and for any time it takes to recover from the after-effects of vaccination. He announced a paid leave tax credit that will offset the cost for employers with fewer than 500 employees to provide full pay for any time their employees need to get a COVID-19 vaccination or recover from that vaccination. The Internal Revenue Service (IRS) released and posted a <u>fact sheet</u> to educate employers on how to claim the paid sick leave credit on their quarterly tax filings. The U.S. Department of the Treasury also outlines the tax credits available to small employers in their press release <u>here</u>. Moreover, President Biden called on employers to use their unique resources to provide information about how people can get vaccinated and why people should get vaccinated.
