New Telehealth Legislation Action Alert for Members. LeadingAge national sent an action alert to all members asking them to urge Congress to support and pass key legislation that will maintain and enhance telehealth for providers and older adults, including the PACE audio-only telehealth bill. Rescue Plan OAA State Funding Disbursed. The White House announced that the \$1.4 billion for OAA programs were disbursed to states and grantees this week. ACL released by-state/by-OAA title allocations for the American Rescue Plan funding for Older Americans Act programs. Most of these dollars will flow to area agencies on aging, and while they won't directly go to PACE organizations, the enhanced funding for the AAA network could create local partnership opportunities between AAAs and PACE organizations.

Trust for America's Health Releases New Report on Homebound Vaccination. <u>Ensuring Access to COVID-19 Vaccines for Older Adults and People with Disabilities Who are Homebound</u>, recommends actions that federal, state, and local government, state and local health agencies, the healthcare sector and community partners should take to ensure that people who are homebound are vaccinated. The report is an outgrowth of two national expert convenings hosted by Trust for America's Health. Funding for the report and convenings was provided by The John A. Hartford Foundation and the Cambia Health Foundation. LeadingAge participated in the expert convenings.

Where Things Stand with Vaccines. On May 12, CDC will vote on and likely approve the use of the Pfizer vaccine for children ages 12-15. Such an approval would open the Pfizer product to millions of teens, including children of workers in aging services settings. In addition, Pfizer and Moderna have indicated this week that they will soon apply for their respective vaccines to be fully approved rather than via an emergency use authorization. If a full approval occurred, more provider settings and/or employers may condition employment on vaccine status. Speaking of...

Vaccinations as a condition of employment. Andrew Banoff of Jewish Senior Services joined one of this week's Coronavirus Update Calls. As of this month, vaccination will be a condition of employment for all staff at Jewish Senior Services (which provides a mix of nursing home, assisted living, home care, and day services). While not a PACE organization, PACE members may find insights from this interview helpful if/as they consider similar mandates for their staff.
