

## **Senior Housing Weekly Update**

March 26, 2021

**Monday, March 29, Housing Advisory Group Call**. Join us for our regular LeadingAge Housing Advisory Group calls on Mondays at 12:30pm ET. On March 29, we'll discuss updates on COVID-19 Supplemental Payments, vaccines and reopening, broadband access, and other issues. On April 5, we'll be joined by a special guest to discuss approaches for managing rising insurance premiums in housing community. **Vaccine confidence with Black Coalition Against COVID Co-founder.** Join us on Mondays, Wednesdays, and Thursdays at 3:30pm ET for COVID-19 updates across the aging services continuum. On Monday, March 29 we'll hear from our <u>town hall</u> partner, Reed Tuckson, a founder of the Black Coalition Against COVIC. He will talk about vaccine confidence, what can be done to influence it, and whether staff acceptance, particularly staff of color, is changing. On Wednesday we'll talk with Dave Wilkinson head of Yale's Tobin Center for Economic Policy and former WH appointee, who will bring a new tool for understanding a nursing home's risk level based on staff movement across multiple providers.

**Draft Bill Circulated on Housing COVID-19 Relief.** The House Committee on Financial Services is circulating a discussion draft of the Supporting Seniors and Tenants in Subsidized Housing Act. The draft bill, a version of 2020's Emergency Housing Assistance for Older Adults Act introduced in the House (as HR 6873) and Senate (as S 4177). The draft bill is sponsored by Representative Emanuel Cleaver (D-MO), the chair of the Financial Services Subcommittee on Housing, Community Development, and Insurance. The bill, spearheaded by LeadingAge, would provide financial relief COVID-19-related expenses,

including funding for new Service Coordinators, funding for the installation and service fees for buildingwide wireless internet, and funding to cover an array of COVID-19 expenses amassed by HUD-assisted affordable senior housing providers. Read the <u>article here</u>.

Adrianne Todman to be Nominated as HUD Deputy Secretary. This week, President Biden announced his intent to nominate Adrianne Todman, CEO of the National Association of Housing and Redevelopment Officials (NAHRO), as Deputy Secretary of HUD. Before joining NAHRO in 2017, Todman served as the Executive Director of the District of Columbia Housing Authority (DCHA) and served in several career positions at HUD. LeadingAge applauds the nomination for the second in command position at HUD and looks forward to working with Todman on our key policy priorities once she is confirmed by the Senate.

**New HUD Guides for Multifamily Housing Released.** On March 22, HUD's Office of Multifamily Housing released new tools for residents and owners. HUD has a new guide for tenants and owners, "Rights and Responsibilities for Tenants & Property Owners" and a new guide for tenants, "Managing Your Finances During COVID-19 Pandemic." The Rights and Responsibilities guide is an easy-to-read breakdown of HUD and CDC guidance with "rights and responsibilities" columns for owners and tenants on several COVID-19 topics: keeping units safe, keeping common areas safe, accessing units for repairs or inspection, eviction protection, protections and accessibility modifications for people with disabilities, and moving. **FCC Staff Discuss Emergency Broadband Benefit Program.** On March 22, staff from the Federal Communication Commission (FCC) new Emergency Broadband Benefit (EBB) program joined LeadingAge's Housing Advisory Group call to discuss how the new program could help affordable senior housing residents as well as housing providers. This <u>article</u> also describes how the EBB program will work for bulk internet contracts. The EBB will provide support to eligible households with discounts for internet service for \$50 per month, per household and a one-time up-to-\$100 subsidy for a device such as a phone, tablet, router, computer, etc., for as long as the \$3.2 billion provided via the December 2020 COVID-19 relief bill for the program lasts. After the EBB program ends, according to FCC staff, the internet service provider must allow EBB participants to remain on the program at the pre-discounted rate. The EBB program is not enrolling subscribers just yet. The FCC is putting finishing touches on the program and anticipates having public enrollment in weeks, not months, FCC staff said.

**IRS Hosts Public Hearing on Average Income Set-Aside.** In a public hearing hosted today by the Internal Revenue Service, housing stakeholders pushed for a reversal of IRS guidance on the Average Income Test for Housing Credit properties. LeadingAge members were strong supporters of the AIT as a way to reach lower income households through the Low-Income Housing Tax Credit (LIHTC) program, but needed more clarity for implementation. Rather than providing clarity, the IRS's October proposed rulemaking included a number of concerning restrictions. In December, LeadingAge submitted comments to the IRS recommending alternate approaches for AIT implementation; throughout the teleconference hearing, witness testimony focused on three issues featured in LeadingAge's December comments to the IRS, including Permanently Fixed vs. Floating Unit Designations; Unit vs. Property Non-

Compliance of the Minimum Set-Aside; and Time Periods for Mitigating Actions. LeadingAge will continue to work with the IRS to ensure that the new Average Income set-aside remains a viable option for reaching more older adults with low and extremely low incomes. **Funeral Costs for COVID-19-Related Deaths**. In early April, FEMA will begin <u>providing financial assistance</u> for funeral expenses incurred after Jan. 20, 2020 for deaths related to coronavirus (COVID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized yesterday, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.
