New Piece on Older Adult Renters and Eviction. A new blog, "On the Edge of Eviction: Emergency Rental Assistance Is a Lifeline," by LeadingAge's Alisha Sanders, senior director of housing and services research, has been published for the American Society on Aging's *Generations*. The blog looks at the number of older adults who believe they're at risk for eviction, who are behind on their rent, and the new emergency rental assistance resources available to them and their landlords. State-Level Projections of Older Adult Renters. New data released from the Urban Institute show statelevel projections for older adult renter growth between 2020 and 2040. As the number of older adult households dramatically expands, homeownership among older adults will decrease, older adult renter households will increase by an astonishing 5.5 million, and a large share of new older adult renter households will be non-white. According to a blog to Urban Institute researchers Laurie Goodman and Jun Zhu, the state level projections "illustrate how needs differ by state and identify the states where the senior renter growth is the most rapid and the need for housing solutions is most acute." The researchers call for an expansion of HUD's Section 202 program to meet the greatly expanding need for affordable senior rental housing. HUD Physical Inspection Bill Introduced. Three members of Congress have introduced the "HUD Inspection Act of 2021," which would expand HUD's response to properties within its subsidized portfolio with low physical inspection scores. The bill follows an April 29 letter to HUD Secretary Marcia Fudge from Senator Marco Rubio (R-FL) on ramping up HUD physical inspections. It also provides considerations to help jurisdictions ensure equal opportunities for vaccination of these populations. 

- \$600 million for approximately 6,700 new Section 202 Supportive Housing for the Elderly homes.
- \$100 million for 400 new three-year Service Coordinator grants.
- \$100 million for the installation and service fees for building-wide internet in 3,300 senior housing communities.
- Full renewal funding for Project-Based Rental Assistance, Project Rental Assistance Contracts, and Service Coordinator grants.
- RAD for PRAC improvements.
