Monday Coronavirus Update Call. New vaccines, new boosters, and new variants as we head into summer, what does it all mean? On Monday, June 13, at 3:30pm ET, we will be joined by Dr. Jeffrey Shaman, professor, Environmental Health Sciences (in the International Research Institute for Climate and Society/Earth Institute), and director, Climate and Health Program, Columbia University, to discuss what we can expect and to answer your questions about new boosters and vaccines. LeadingAge Pushes Back on Limits to Services and Other Changes in Section 8 Rent Setting. In response to Section 8 rent setting policy changes proposed by HUD, LeadingAge has pushed back strongly to preserve the federal government's investments in non-shelter services at HUD-assisted senior housing communities. Earlier this year, HUD proposed revisions to Chapter 9 of the Section 8 Renewal Guidebook to adjust the process for Rent Comparability Study appraisal valuations. The proposed changes impact project-based Section 8 properties, including Section 202/8, undergoing an RCS to establish the value of non-shelter services provided at the property; the proposed changes also adjust the appeals process for the appraisal, the administrative cost and workload for the RCS, and the valuation of internet access at the property. HUD Funding Votes Scheduled, Advocates Press Congress. The House Committee on Appropriations has scheduled votes on its fiscal year 2023 HUD appropriations bill. The time between now and the votes is an excellent opportunity for housing stakeholders with Representatives on the full appropriations committee or its HUD subcommittee to communicate affordable senior housing priorities to these key decision makers. The FY23 HUD bill will be considered in the Appropriations Subcommittee on Transportation, and Housing and Urban Development, and Related Agencies on June 23; the full Committee will consider the bill on June 30. <u>Full Committee members</u> and <u>HUD Appropriations</u> <u>Subcommittee</u> members, especially, should hear from housing stakeholders now. Now is the time to urge your Senators and Representatives to increase funding for affordable senior housing to preserve and expand affordable housing for older adults with very low incomes. Rising Housing Costs for Older Adults, LeadingAge Member Culpepper Garden on CNN. Senators Seek Input on Rural Housing Service. Following up on their <u>May hearing</u> on rural housing, Senators Tina Smith (D-MN) and Mike Rounds (R-SD), Chair and Ranking Member of the Senate Banking Subcommittee on Housing, are requesting input from stakeholders on Rural Housing Service programs. Interested stakeholders can submit their proposals directly to <u>Rural_housing@smith.senate.gov</u> by July 8. Any submission may be made public, so submitters should not include confidential or business sensitive information. Submissions should be included the body of an email or as a .pdf file, with a clear name of the author, any affiliated organization, and appropriate contact information. Interested in Pursuing a Master Plan on Aging in Your State? The Center for Health Care Strategies released a new tool today, <u>Developing a Master Plan for Aging</u>. Many LeadingAge state partners and members have watched California develop, promote and begin to take action on a Master Plan on Aging (MPA). An MPA is a cross sector, state led strategic planning resource that can help states transform the infrastructure and coordination of services for their rapidly aging population, as well as people with disabilities. Stakeholders, even those in states that might have developed more traditional aging plans in the past, see hope for more progress and organized strategies through this approach. The new tool outlines the core tenets for how to develop an MPA in your state, with best practices and state examples throughout.

LeadingAge to Host Call on Policy Changes to Criminal Background Screening. Join LeadingAge on June 22 at 1pm ET to help provide feedback to HUD about changes to criminal background screening at affordable housing properties. In April, HUD Secretary Marcia Fudge announced an <u>agency-wide effort</u> to remove barriers that prevent individuals with criminal histories from participating in HUD programs. As a result, HUD offices are working to identify all existing HUD regulations, guidance documents, and other policies that may pose barriers to housing people with criminal histories; the review includes regulatory and sub-regulatory documents like model leases and other agreements. By October 14, 2022, HUD offices are directed to propose updates and amendments to the agency documents and guidance to make HUD programs as inclusive as possible for individuals with criminal histories. Join LeadingAge for a call to discuss the process of criminal background screening at senior housing properties and the potential impact of HUD's policy changes, and help create feedback for HUD as they undergo their review of agency guidance. Affordable Connectivity Program Outreach Materials. The Federal Communications Commission has pulled together outreach tools for the Affordable Connectivity Program. Consumer awareness flyers, social media content, fact sheets, infographics, audio PSAs, a consumer FAQ, a search tool for participating internet service providers offering the Affordable Connectivity Program discount, and

information on how to sign up into <u>one website</u>. Most materials are available in English and Spanish and many are also available in Arabic, Chinese-Traditional, Chinese-Simplified, French, Haitian-Creole, Korean, Portuguese, Russian, Tagalog, and Vietnamese.
