Action Alert: Affordable Senior Housing Funding. On September 10, LeadingAge issued an action alert to urge aging services stakeholders to ask Senators and Representatives to increase and adequately fund HUD affordable senior housing programs in fiscal year 2025. There are large differences between the House and Senate FY25 HUD funding bills; the alert helps inform policymakers to support the strongest possible funding as Congress works to complete its FY25 HUD funding bill over the coming months. Congress Begins Consideration of Spending Stopgap. Congress is back in session as of September 9, with completing a continuing resolution by midnight September 30, the last day of fiscal year 2024 (FY24). On September 6, Representative Clay Higgins (R-LA) and House Committee on Appropriations Chair Tom Cole (R-OK) introduced <u>H.R. 9494</u>, a CR that would fund annually appropriated federal government programs at FY24 levels through the first six months of fiscal year 2025, until March 28,

2025. At a September 9 House Committee on Rules meeting on the rules under which the House will consider the measure as soon as September 11, Democrats voiced opposition to a six-month CR as well as H.R. 9494's provision that would require proof of citizenship in order to register to vote in federal elections. Congress has yet to enact any of the 12 FY25 appropriations funding bill despite the looming October 1 start to FY25. While mandatory spending programs like Medicare and Medicaid are not impacted by CRs because these are not annually appropriated programs, HUD funding is annually appropriated and thus directly impacted by a CR. LeadingAge's assessment is that keeping HUD programs funded at only FY24 levels for half of FY25 is a potentially dangerous proposal, one that could leave HUD with insufficient funds to renew rental assistance contracts with affordable senior housing providers at a full level and / or for full 12 month terms.

Supportive Services for Housing Bill Introduced. Representative Pete Aguilar (D-CA), a member of the House Committee on Appropriations, introduced the Affordable Housing Resident Services Act on September 12. The bill would expand eligible grantees and eligible grant uses of the existing Affordable Housing and Supportive Services Demonstration, which is administered by HHS's Administration for Children and Families. Under the bill, a broad array of housing providers would be eligible for the program's grant funding, including low income housing tax credit, Section 202, and project-based Section 8 properties, etc. Affordable housing properties could use up to 25% of funding received under the grant for a service coordinator at the property; remaining funds could be used to provide supportive services to residents. Eligible services funded by the grant would include supports for older adults, mental health, alcohol and addiction treatment, educational opportunities for youth and adult residents, after-school programs for children and teenagers, self-sufficiency resources, resources on future home ownership, financial literacy training, assistance to residents with disabilities, and other community services. "As we work to address the nation's housing crisis and California's homelessness epidemic by building more affordable housing, the importance of connecting residents with quality supportive services is even more vital to help them succeed," Representative Aguilar said in a statement upon the bill's introduction. LeadingAge worked with staff on the bill, which LeadingAge supports.

COVID Test Kits available for HUD, Home Health, and Hospice Providers. LeadingAge has received confirmation that home health and hospice agencies are eligible to request COVID test kits upon request to the Department of Health & Human Services (HHS). LeadingAge has confirmed with HHS that the program continues at this time and into 2025. Nursing homes, assisted living, home health, and hospice providers can request to be added to weekly distributions by emailing TDX@hhs.gov and providing their shipping information. Any requests to increase, decrease, pause, or re-initiate shipping should also be sent to TDX@hhs.gov. HHS states that requests are usually processed within a couple of weeks of being received. HUD multifamily affordable senior housing providers can order free test kits through this portal. LeadingAge understands how vital this program is for our members. We are grateful that the

Administration continues this program and we <u>continue to advocate</u> for access to tests, vaccines, and therapeutics for aging services across the continuum.

HUD Awards \$10 million to Support Tenant Capacity Building. On September 10, the U.S. Department of Housing and Urban Development (HUD) awarded \$10 million in grants to expand tenant education opportunities and resources for low-income residents of certain HUD-assisted multifamily properties. The funding will support capacity building efforts that enable thousands of tenants who live in HUD's project based rental assistance housing to more effectively engage with property managers and owners to help sustain safe, decent, and affordable housing. According to HUD, the program will help tenants in their efforts to work productively with property management, hold management accountable for property conditions, improve management and oversight of these multifamily properties, and advocate to preserve affordability. Funds awarded to the tenant advocacy organizations are available through HUD's Tenant Education Outreach (TEO) Program and will enable the AIDS Healthcare Foundation—in partnership with the Massachusetts Alliance of HUD Tenants—to strengthen tenant organizing groups. These organizations will make funds available over the next two years to approximately 30 eligible tenant advocacy organizations on a first come, first served basis, to build the capacity of tenants as active partners in the preservation of affordable rental housing for low-income residents.
