# LEADINGAGE REPORT PORTAL FREQUENTLY ASKED QUESTIONS

This FAQ is meant to help LeadingAge members understand the origins of a user's Report Portal data, and provide more details on updates.

#### What is the purpose of these reports?

These reports benchmark your organization's data to other relevant benchmarks using the metrics released by the Centers for Medicare and Medicaid Services (CMS).

## Where is this data from?

The data contained in this members-only tool comes from CMS, which gathers information from a variety of sources including survey reports, claims data and provider assessments. CMS uses this data to evaluate providers and to derive quality information shared with consumers on the Care Compare website. All data presented in these reports is also available on Care Compare for individual providers.

## How often are these reports updated?

Reports are updated when CMS releases new data. Because release dates vary, the delivery of new reports is not precise. The two tables below outline when providers can expect new reports, and what each report will contain.
