**SUBJECT: Use of Supportive Services Funds for Wi-Fi¹ in Section 202 Capital Advance
Elderly Buildings**

I. Purpose

This Notice expands the eligible use of supportive services funds to include Wi-Fi in units for Section 202 Capital Advance projects with Project Rental Assistance Contracts (Section 202 PRACs). The Notice supersedes in part Notice H 2023-02,² which outlined the eligible and ineligible uses of supportive services funds in Section 202 PRACs. The Notice also corrects an error in Notice H 2023-02 (See Section VI).

II. Background

Internet access is increasingly essential as more seniors require technology-assisted healthcare services. In 2021, the CDC found that nearly half of seniors aged 65 and older used telemedicine over the prior year.³ Despite these numbers, there remain barriers to access for low-income seniors, namely the costs of Wi-Fi connectivity payments, lack of access to adequate technology, and the learning curve for seniors using digital devices. These problems can be particularly acute for residents of HUD-assisted elderly projects, who are low-income and may struggle to access affordable Internet, even if their building has broadband.

Section 202 PRACs provide affordable supportive housing for very low-income elderly households. The operating budgets at these properties may include up to \$15 per unit per month for the direct provision of supportive services. As discussed in Notice H 2023-02, however, this funding may not be used for Wi-Fi. Through this Notice 2025-08, the Office of Multifamily Housing revises this policy by striking paragraph IV.D.9 of Notice H 2023-02 and establishing conditions for the use of supportive services funds for Wi-Fi.

III. Applicability

This Notice applies to the use of supportive services funds by owners/agents of Section 202 PRACs.

IV. Policy Revision

Notice H 2023–02 states a number of goals for the use of supportive services funds, including (paragraph IV.B.1):

To supplement programming, activities, and services that facilitate independent living in the community by helping participants proactively address their health and social support needs.

Paragraph IV.D.9 of Notice H 2023–02 lists the following ineligible use of supportive services funds:

Wi-Fi Networks and/or internet access for individual residents in their units

In light of the emergence of telehealth and related Web-based services, the Office of Multifamily Housing (MFH) programs has revised its view of the importance of access to Wi-Fi and the Internet, particularly for seniors. Wi-Fi can be considered a “supportive service” to help tenants “address health and social support needs”; therefore, as of the effective date of this Notice, supportive services funding may be used for Wi-Fi networks and/or Internet access for individual residents in their units.

This Notice supersedes Section IV.D.9 of H 2023–02, permitting owners/agents of Section 202 project assisted pursuant to PRACs to use supportive services funds for Wi-Fi payments and Internet connectivity for residents, subject to the conditions outlined in Section V, below.

V. Conditions on Use of Supportive Services Fund for Wi-Fi

Owners/agents of Section 202 PRACs who wish to use supportive services funds for Wi-Fi must:

- A. Update their Supportive Services Plan to fulfill the requirements laid out in section V.A of H 2023–02, and request Supportive Services Funds in accordance with section VI. of H 2023–02. Note regarding section V.A.3: An Owner who elects to use Supportive Services funds for Wi-Fi may not require a tenant to pay for Wi-Fi equipment or Internet service.
- B. Establish a plan for the service coordinator to connect with digital navigators⁴ funded through health plans, philanthropic organizations, or another source to ensure all tenants have assistance to leverage digital resources.

VI. Correction to Notice H 2023–02

Section IV.A.4 of H 2023–02 mistakenly refers to “paragraph III,C” of the Notice rather than “paragraph IV.C.” This Notice corrects that error.
